ANNEX 1 - Adjustments to the auction calendar

The following conditions provide for adjusting the volumes of individual auctions:

1. Final determination of the amount of allowances to be auctioned

The auction calendar has been based on a conservative working estimate of allowances to be auctioned for 2013 under the cap. Any difference between the volumes in the present calendar and the final figures determined pursuant to Article 10(1) of the ETS Directive will be taken into account in an update no later than July 2013. This calendar update would also take into account any back-loaded amounts for 2013, if a decision on the back-loading proposal has been made in the meantime by Council and Parliament.

Delayed appointment, admission or recognition of auctioneers

The allowances to be auctioned on behalf of a Member State or EEA-EFTA State¹ shall be withheld from the auctions whenever that Member State or EEA-EFTA State has not appointed an auctioneer (according to Art. 22(5) Auctioning Regulation) or the auctioneer is not admitted by EEX and recognised by ECC. For the time being, only the auctioneers from the Czech Republic, Ireland, the EEA-EFTA states and Poland have not yet been admitted/recognized.

Similarly, the allowances to be auctioned on behalf of Poland or an EEA-EFTA State shall be withheld from the auctions whenever that State has not concluded a contract with EEX that is mutatis mutandis identical to the contract between EEX, the European Commission and the 24 participating Member States. Furthermore, the allowances to be auctioned on behalf of an EEA-EFTA State shall be withheld from the auctions pending the amendment of the relevant annex of the EEA Agreement to incorporate Commission Regulation (EU) No 1193/2011 of 18 November 2011 (the 'Registry Regulation').

Any allowances that have been withheld from the auctions due to such delay shall be auctioned as from two weeks of the fulfilment of the relevant conditions. As from that moment, these allowances shall be evenly distributed over the next scheduled auctions as follows:

- a. In the case of general allowances, the number of auctions over which these withheld allowances shall be evenly distributed shall equal four times the number of auctions at which the auctioning of these allowances was withheld (*For example:* The sum of general allowances of a Member State withheld from 4 auction dates will be evenly distributed over the next 16 auctions as from two weeks following the auctioneer's admission to the auction platform.)
- b. In the case of aviation allowances, the number of auctions over which these withheld allowances shall be evenly distributed shall equal two times the number of auctions at which the auctioning of these allowances was withheld. (*For example:* The sum of aviation allowances of a Member State withheld from 4 auction dates will be evenly distributed over the next 8 auctions as from two weeks following the auctioneer's admission to the auction platform.)

¹ State that is a member of the European Free Trade Association (hereafter "EFTA") that forms part of the European Economic Area (hereafter "EEA")

3. Cancellation of auctions

In case an auction is cancelled according to Auction Regulation Article 7(5) (i.e. the total volume of bids falls short of the total volume of auctioned allowances), Article 7(6) (i.e. the auction clearing price is significantly under the price on the secondary market) or Article 9 (i.e. other circumstances preventing the conduct of the auctions), the volumes will be distributed as set out in the Auctioning Regulation under Article 7(8) and Article 9, namely:

- a. In case of General Allowances, the volumes will be spread evenly over the next four scheduled auctions.
- b. In case of Aviation Allowances, the volumes will be spread evenly over the next two scheduled auctions.

As set out in Article 45(5) of the Auctioning Regulation, in the event of a failure of settlement the allowances concerned shall be auctioned at the next two auctions scheduled.

Additional notes

- In accordance with the second sub-paragraph of Article 8(4) of the Auctioning Regulation, no other auction platform shall conduct an auction under this Regulation on Tuesdays and Thursdays.
- In view of the Commission's proposal to defer the enforcement of the requirement for aircraft operators to surrender allowances for emissions in 2012 for flights into and out of Europe, the 2013 auction calendars for aviation allowances are not expected to be determined before January 2013. On 16 November, the remaining auctions for 2012 aviation allowances were put on hold. Once the Commission's proposal is agreed, the volume that was originally scheduled for these auctions will be adjusted and will be auctioned in February to April 2013. The auctions of phase 3 aviation allowances will start from May 2013.
- Article 14(1) of the Auctioning Regulation provides for various situations where the present auction calendar may need to be modified, but where the precise manner in which the modification is to be implemented is not provided for in the present auction calendar. In such situations, EEX will determine and publish an adjusted auction calendar.
